Among the early arrivals in Hillsboro was Past Master and former Secretary Gordon Kelso, who has been missing from TLR functions for far too long.

After a good night's sleep, members, fellow Masons, and their ladies assembled at Hillsboro's lodge hall for kolache pastries and coffee in preparation for the day's events. Past Masters Plez Transou, FMR, and Chuck Bukin, drove in from Dallas as did Jerry Kirby from Red Oak. East Texas was well represented by John Dougherty III and the southern Gulf Coast by Editorial Committee member Herb Arbuckle of Corpus Christi. Grand High Priest of Texas and PM Doug Collins, Lady Cheri and their poodle were also in attendance.

District Deputy Grand Masters who signed the register included Bob Umphrees (14-A), Richard C. Sharp (30-H), Joe Maxwell (63), Danny Rymers (68) and Max Omberg (62).

Grand Lodge officers included Grand Photographer Don Comedy, Grand Senior Steward Clyde Kenneaster, PM, FM, and Grand Junior Warden and TLR PM Jim Brumit.

Incoming Worshipful Master Harper who, by the way, is also City Manager of Hillsboro, had arranged special tours of the historic Hill County Court House and Hillsboro's Outlet Mall for

the ladies.

Worshipful Master Bradley, as the business of the lodge was coming to an end, called for the election of officers for the coming Masonic year. The following were nominated, seconded and elected unanimously: Jack Harper, Worshipful Master; Wayne Sirmon, Senior Warden; Merlen Howe, Junior Warden; Mark Dermit, Treasurer; Jim Dougherty, Secretary.

Following the morning tiled business meeting, the lunch crowd almost doubled and enjoyed a tasty barbecue meal. The afternoon's open meeting was called to order at 1 p.m. for a paper presentation and installation of officers.

As the lodge reassembled for the afternoon session, many more chairs had to be brought into the hall to accommodate another 40 or so Masons and guests.

Full Member James McCrae presented his second research paper, which was a great tale of late 19th Century Texas Rangers, the Indian skirmishes in

West Texas and the Masonic connection.

Grand Master and retiring TLR Marshal David Counts assumed the East and, assisted by Past Grand Masters David Dibrell, Installing Marshal and Leonard P. Harvey, Installing Chaplain, installed the 2009 lodge officers.

Newly installed Worshipful Master Harper called attention to the close ties between Freemasonry, Hill County and its county seat of Hillsboro. He mentioned the fact that when the historic court house was burned to a shell, then Lt. Governor and Hill County favorite son Bob Bullock, furnished recycled wooden flooring from the also fire-devastated state Capitol to restore the district courtroom. The \$12 million restoration project was also aided by another Hill County favorite son, legendary singer-songwriter Willie Nelson, who organized two benefit concerts for the court house restoration.

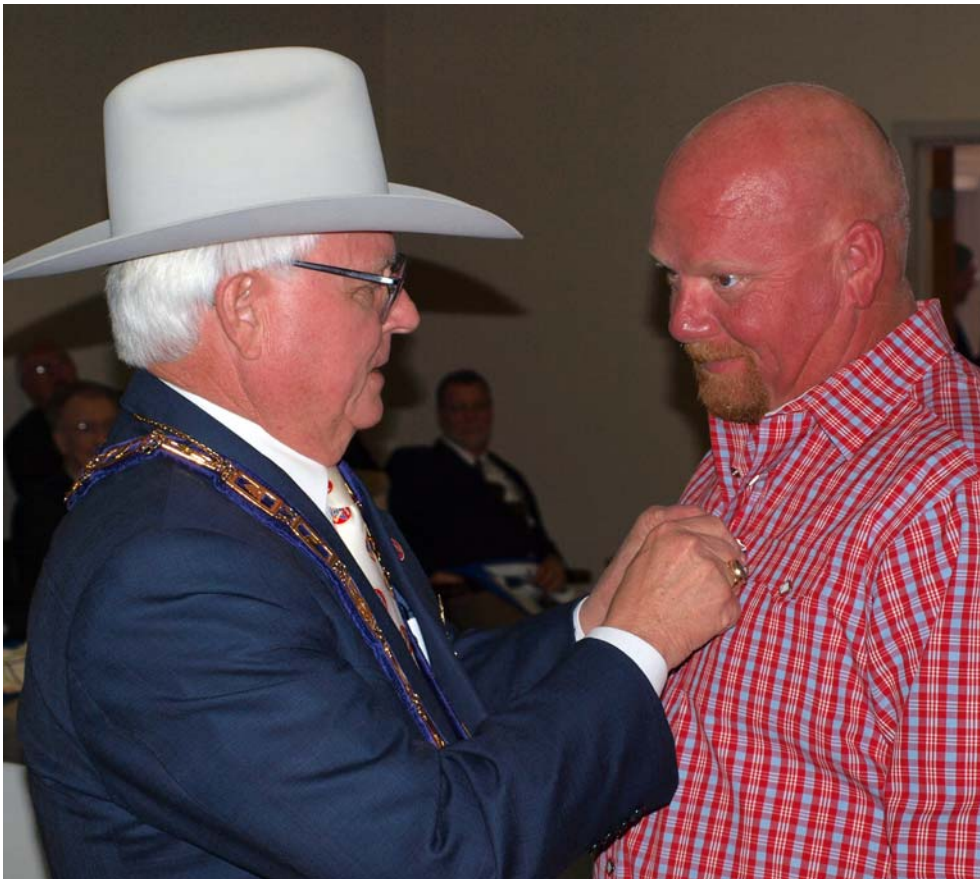

## Editor's Note

Dr. William P. Vaughn, Editor Emeritus of the *Transactions*, was hospitalized in Mount Pleasant after suffering a stroke. He is now at an assisted living facility. Please keep our Brother and Fellow in Masonic Research in your thoughts and prayers.

You will have noticed by the time you get to this column dramatic changes in your TLR *Occasional Bulletin* ... eight pages and all in glorious color!

The transition to this new format came as bit of serendipity. For many years, the *Transactions* of Texas Lodge of Research were typeset, proofed and printed by the Masonic Home and School Press in Fort Worth. A couple of volumes were even “farmed out” to the Masonic Home and School in Oklahoma. Those were the days when our charitable activities not only took in students for general public school education, but also taught practical trades. Printing was a big part of that trade school mission.

Unfortunately, the MH&S print shop closed and TLR had to enlist other printers to produce both the annual *Transactions* and the quarterly *Occasional Bulletin* newsletter. With time and a changing economy, the leadership of TLR found that producing and mailing of these periodicals took an increasing and then onerous toll on the TLR budget.

In late 2008, it was called to our attention that the Austin campus of the Texas School for the Deaf has a trade and technology department (print shop.) This print shop needs publications to train its students. Several local Masonic lodges, as well as the Grand Royal Arch Chapter and Council of Texas, and other nonprofits, now utilize the Deaf School to produce their publications. These nonprofits benefit from less expensive newsletters, while the students benefit from actual, real-world experience.

Our *Transactions* are another issue. Printing, binding and mailing of the annual report of research papers presented, meeting

proceedings, necrology and membership roster evolved into a project that amounted to more than half of the former annual dues collected from each member, or associate.

Worshipful Master Bronk, followed by Worshipful Master Bradly concurred that the membership list of over 1,200 needed to be examined. The rolls included about 500 “members” who had not contributed a dues payment for two or more years.

As a “Special Lodge,” TLR does not report members NPD (Non-Payment of Dues) to Grand Lodge, which would jeopardize one’s membership in his other Blue Lodge affiliations. When a member of TLR discovers he hasn’t paid dues and wants to reaffiliate, no harm done, and the current year’s dues will be all that’s needed to be reinstated.

The formerly excessive press runs and postage for those members who have not been contributing to the lodge have been eliminated. Our membership has stepped up and contributed the moderately increased and much needed dues support, TLR has returned to the financial “black” for the first time in several years. Prospective new members are filing applications at a great rate thanks to several of our Full Members. Thank you, one and all.

At the Hillsboro quarterly meeting, a great, young leadership was installed. Texas Lodge of Research is in good hands as we enter our next 50 years.

# Fletcher to be Anson Jones Lecturer at Richardson meeting

Texas Lodge of Research and the Annual Anson Jones Lecture return to the Metroplex on June 19-20. Host lodges, Richardson No. 1214 and Eagle No. 41, have promised to roll out the red carpet at their beautiful lodge hall located at 528 Lockwood Drive in Richardson.

Richard E. "Dick" Fletcher, P.G.M. of Vermont, has been selected as the 33rd Anson Jones Lecturer of Texas Lodge of Research. He is best known internationally as the Executive Secretary of the Masonic Service Association, headquartered in Silver Spring, Md., a position he has held for 21 years. His duties in that office include the role of Editor of the *Short Talk Bulletin*, *Emmessay Notes*, and all other publications of the M.S.A. Brother Fletcher regularly visits Grand Lodges throughout North America, speaking and representing the M.S.A. His extensive knowledge of Freemasonry makes him a good representative of the fraternity, and he is frequently interviewed for documentaries produced for various cable television channels.

Brother Fletcher is a native of Maiden, Mass. He attended public schools in Jeffersonville, Vt., and later served in the U.S. Navy. He is a Past Master of Burlington Lodge No. 100 and served as Grand Master of Vermont, 1983-85. He is a 33rd Degree Scottish Rite Mason (N.M.J.) and a member of the York Rite in Vermont. Bro. Fletcher's lecture is one not to be missed.
