Introduced by the then-junior Fellow in Masonic Research and fellow *Aggie*, Pierre "Pete" Normand, the topic of his Fellows presentation was the history of Freemasonry.


It's been a great year!


This meeting will be hosted by historic Valley Lodge No. 175, which is located at 311 S. Main (one block south on Main from the west side of the county courthouse square.)
